**Carter BloodCare and Stewart Regional Blood Center agree to merge.** Dallas/Fort Worth-based Carter BloodCare and Tyler-based Stewart Regional Blood Center announce that the two organizations will merge later this spring. Both centers have deep community roots, dating back to the 1950's, and together provide more than 330,000 units of life-saving blood annually for patients in nearly 300 hospitals in 56 North Central and East Texas counties.

"By joining forces, these two Texas institutions will combine more than 160 years of bloodbanking expertise to help meet growing healthcare demands in our region," says Carter BloodCare president and CEO, Dr. Merlyn Sayers. "Together, we will continue to build on a long-standing tradition of serving patients by making transfusions possible in our communities."

The decision to merge was made following a rigorous review and unanimous vote by the board of directors of both centers. An interim management agreement is now in effect until the merger on or before April 1, 2007. Jointly, Carter BloodCare and Stewart will work to consolidate business operations, maximize blood donation and promote high standards for excellence in community blood banking.

Once fully merged, Carter BloodCare and Stewart will be able to welcome donors at 26 permanent donor centers, host up to 30 daily blood drives, maintain a fleet of more than 110 donor coaches and distribution vehicles, and employ nearly 1,000 Texas residents. The organization will also provide unique specialty transfusion services including the Tyler HLA

testing laboratory, the second-largest database for HLA matched platelets in the U.S., two branches of the National Marrow Donor Program, a rare donor registry and around-the-clock consultation with on-staff medical directors.

"While this merger increases the services we can provide, dedicated blood donors are at the very heart of our community blood program," says Stewart Regional Blood Center COO, John Drury. "We encourage them to continue sharing the gift of life at our donor centers and blood drives."

Carter BloodCare and Stewart Regional Blood Center are not-for-profit, community-based blood centers, accredited by the American Association of Blood Banks, licensed by the Food and Drug Administration and affiliated with America's Blood Centers.

**Janet Schwetz has joined the Coastal Bend Blood Center (CBBC)** as director of technical services. Ms. Schwetz comes to the CBBC after 17 years with UBS, Tupelo, Mississippi. ### Dr. Peschel

I served as chair of the AABB committee on I&A for Texas, Oklahoma, and New Mexico from 1977-1993. I was a member of AABB standards committee from 1985-1989, and I was consultant from 1989-1997. I served as president of the South Central Association of Blood Banks from 1982-1983 as well as president of the Tarrant County Medical Society in 1983. I was secretary of the Texas Medical Association from 1986-1989. I was a member of the Transfusion Medicine Committee for the American Society of Clinical Pathologists from 1986-1989. I shall always remember working long hours with fellow blood bankers, John Milam MD, Shannon Cooper, MD, Ron Gilcher, MD, Ray Bryant, MD, Herb Polesky, MD, and Toby Simon, MD, during these difficult times.

Challenges continued into the '90s. This decade produced additional regulatory oversight from federal agencies including the FDA, HCFA, and OSHA. During these years I served on the AABB Board of Directors from 1989-1993, I was a member of the College of American Pathologists Transfusion Resource Committee from 1991-1995, and I served as president of the Texas Society of Pathologists in 1990.

My dream for years was that we would have a regional blood bank in north Texas. That dream was realized through the efforts of Merlyn Sayers, MD, and Bobby Grigsby when Carter Blood Center and BloodCare merged. Since my retirement in 1997, I have served Carter BloodCare as medical director emeritus, as well as on the medical advisory committee and the board of directors.

The photo of me tells one last story. I have always loved Ft. Worth, and since my retirement I set out to accomplish 3 personal goals: 1) I wanted to ride in the Fort Worth Stock Show, 2) I wanted to be on Billy Bob's stage, and 3) I wanted to model in a style show. My first goal was realized when I chaired the centennial committee for Tarrant County Medical Society and rode in the stock show parade. My second goal was realized when I announced the amount of money raised from health facilities for the United Way campaign from Billy Bob's stage. My third goal was realized when I was asked to model in a style show at the Ft. Worth convention center to raise money for the Tarrant County Alliance for their community projects. My photograph was taken at that style show. (I was the only one in the style show wearing a hat!)

I gratefully acknowledge the support of my husband, Logan, daughters, Penny and Patti, and my grandchildren, Jaelyn, Blake, and Emily. Their love and respect are life's sweetest rewards.

A blood banker's life is tough, but interesting. I feel that I have been blessed to have had a role in helping to make the nation's blood banks what they are today!
